

Challenge Games

All challenge games must be log on the online application

Referees cannot referee their own clubs' games

Clubs must provide the Referee with written confirmation that the game has been logged on the online system – An email or text from an offical club address will be sufficent

Return to Play

As things stand spectators are not permitted-

The maximum number that can attend an outdoor gathering is 30 people

(an exemption has now been applied for those that 'are taking part in or assisting with a sporting event.')

This basically means unless you have an official role at the event you can't attend;

The GAA don't control the level of attendees at outdoor events







Match Regulations

• A maximum of 24 players inside the enclosed pitch area during the game

 A maximum of 5 (Football) and 7 (Hurling) team officials allowed inside the pitch area

•Subs / team officials to be positioned on opposite sides of the pitch



Water carriers are not permitted in either Football / Hurling games





2 Hurley carriers are permitted in Hurling,

but they can't carry water!

(They are part of the 7 officials)



One water break will take place between the 15th & 20th minute of each half at the referee's discretion.

It will last for 1 minute

The referee has the authority during the game to send any person in breach of the regulations outside the pitch enclosure and such persons cannot be replaced



Return of Spectators



It is essential that clear and concise information is made available to spectators before they consider attending any club games

Spectators should be aware that all the risks posed from Covid-19 cannot be eliminated, including attending GAA games but that essential control measures have been put in place to reduce risks for members.

Spectators must **not attend games if they display any symptoms** of Covid-19 and instead should phone their GP and follow public health advice

Individuals must be informed that much of the responsibility for managing Covid-19 risk remains with themselves particularly in relation to social distancing, wearing of face coverings and sanitation

All spectators should be encouraged to bring their own hand sanitiser

The cumpulsory use of face coverings for all patrons over the age of 13

Spectators must not enter the field of play at any time including pre-match, at half-time and other intervals and after the final whistle or at end-of-match presentations

Spectators should be advised to keep their own record of contacts at a match for potential tracing purposes





Every Person

(man woman and child) will have to be recorded by an appointed person at each venue when they attend a game



Recording Attendance

The number in attendance should be recorded by the club hosting the match to ensure that government guidance has been fully complied with.

A designated person should be appointed to carry out this task.





Sanitation and Toilets

Grounds must ensure that there are adequate male and female toilet facilities available for the expected attendance

Ensure toilets are well ventilated and there is a robust documented cleaning regime in place

Hand sanitiser stations should be located at entry points and at other key touchpoint areas where handwashing facilities are not available

Match Day Personnel

All players, officials, and volunteers must have completed GAA questionnaire and online training

Clubs should designate a competent individual to ensure there is compliance with all relevant Covid-19 guidance (someone who can dedicate sufficient time to the role)

Appropriate stewarding arrangements (based on risk assessment) should be put in place

Contact Tracing

All practical measures should be taken to inform spectators attending to restrict contact with individuals and groups outside their own household once inside the ground e.g. through public announcements, signage and stewards.

Host clubs will be responsible for the contact tracing records of volunteers, players and officials.

Host clubs are not responsible for the contract tracing records of spectators

Ticketing

For games with an expected attendance of 200 or more it is recommended that entry should be by pre-paid ticket only (to include spectators and non-spectators and complementary)

Tickets must be purchased in advance of the game.

The ticket allocation for spectators must be determined from the maximum capacity? minus the expected number of players, support staff, ground staff and volunteers, officials and all others present in a non-spectating capacity
