Club Governance & Basic Essentials Required for Funding Applications

A list of things to have (non exhaustive list and varies between funders):

- Constitution
- Management Committee
- Active Bank Account
- Most Recent Annual Accounts
- Elected officers and committee
- Relevant policies e.g. Safeguarding, H&S
- Club Development Plan
- Insurance Cover
- ✓ AGM / Annual Report / Meeting Minutes

Accreditation

Completing your Club Accreditation will automatically mean most of these requirements are already in place.

It may also increase your chances of grant success as it demonstrates to funders that you meet a nationally recognised quality standard.







FUNDING

Funding Application Tips (do's)

- Research into the most appropriate funder(s) to meet club requirements. If your request doesn't meet the funders criteria then you are applying to the wrong funding source.
- Read the eligibility criteria and the guidance notes before starting the application. You don't want to waste time writing an application if you don't meet the criteria.
- Be clear about what you want to achieve.
- Contact the funder before starting to fill in the form. Don't be afraid to ask questions. It is also a good opportunity to talk about your project and see if the funder would be interested to fund your club and project.
- Ask for a contact name from the funder so that you can talk to them again if required.





Funding Application Tips (do not)

- Make spelling mistakes or use abbreviations or jargon
- Make vague statements about what you want to do
- Send in lots of information unless the funders have specifically asked for it
- Forget to include all expenditure items and overheads in the costs. Also allow for VAT and inflation
- Send a standard or a begging letter
- Expect to be successful. There are hundreds of other voluntary organisations applying for the same pots of money





Funding Application Tips (do not)

- Assume that the funders know about you. You need to be very precise when completing an application form
- Apply for the maximum funds available but build your project based on needs
- Don't leave it to the last minute
- Don't forget grants are not the only way to bring in money. There are a wide range of other sources such as fundraising event, donations, members subscriptions, partnership/collaboration etc
- Give up if your application is unsuccessful, ask for feedback from the funders and then try again



Most Common Blunders

1. Projects are not well planned or thought out

2. Applicant is not eligible due to its legal, lack of charitable status, size or geographical remit.



3. Applicants do not identify the 'need' for the project

4. The applicant fails to demonstrate that they meet the criteria

5. Applications are made but fail to identify the monitoring and evaluation processes in place



Most Common Blunders

6. Applicants asking too much or too little and budgets do not add up

7. The applicant misses the deadline



8. The form is incomplete or illegible (e.g. missing signatures etc.

9. The application enclosures are incomplete, inaccurate, out of date, contradict the application form or are simply not enclosed.

10. The applicant does not have the appropriate systems, policies and procedures in place

- Funding fairs/events.
- Social media (e.g. Twitter, Facebook).
- Word of mouth.



GRANT MAKING ORGANISATIONS Types of Grant-makers

Range of sources for grants can be categorized in different ways but normally the list would be as follows:

Statutory: Government Departments (e.g. The Executive Office, Health, Education, **Department for Communities**, DAERA etc.) and local district Councils, European Union (e.g. Peace funding = Peace IV)

Voluntary: Independent Grant-making Trusts/Foundations (e.g. Garfield Weston, John Moores, Esmee Fairbairn)


Private: Businesses who wish to give back some of their profits into worthy causes (e.g. Asda, Bombardier, Halifax Foundation NI)

PHASE ONE: EXISTING AND PLANNED FUNDING

• Sport NI is getting monies, already allocated through their Lottery funded programmes, out to eligible governing bodies of sport and sports clubs & organisations quickly, as announced by the Minister on 30th March.

• To ensure that sports will have money to pay staff, alleviate cash-flow concerns, provide assurance to staff, and keep the organisations afloat.

•Sport NI is working hard on a range of ways to flexibly support your organisation through this crisis and beyond, and commits to having a single point of contact within the organisation for such situations.

PHASE TWO: HARDSHIP FUNDING

- Fund offering clubs **£2000** to maintain club and facilities
- Initial funding of £500,000 has been increased by a further £250,000 through the reallocation of exchequer funding
- scheme opened 14th April BUT was suspended 16th April pending the assessment of those applications already been submitted.
- **350 clubs** had applied by lunchtime on Thursday 16 April
- Scheme may re-open subject to additional funding becoming available
- expect to begin making initial payments to eligible applicants, over the next five working days.
- Sports are working closely with the Department for Communities to identify and secure additional funding for the Sports Hardship Fund.







Business and hospitality grants

Coronavirus: £10,000 Small Business Support Grant Scheme

Sports Governing Bodies are urgently calling for the current exclusion of the sports sector, in respect of the small business £10k grants to be lifted for the purposes of Covid19.

Sports governing bodies are in continued dialogue with the government to lobby for support for those clubs who do not qualify for any of the existing funding. Grants for Businesses with a **Net Annual Value of £15,000 and below**.

Business and hospitality grants

Coronavirus: £25,000 Retail, Hospitality, Tourism and Leisure Grant

Grant Registration is **now open** for clubs to apply for the £25,000 Business Grant Scheme for the retail, hospitality, tourism and leisure sectors.

Pre-application check

This is for clubs that have a rateable value between £15001 and £51000. Clubs can complete a preapplication check (by entering the Ratepayer ID and Occupancy ID from your business rate bill), apply for the scheme and provide their bank details by completing the following online application form.

The National Lottery: Awards for All Northern Ireland

A quick way to apply for smaller amounts of funding between £300 and £10,000.

COVID-19 Response:

The application form requires you to insert a project start date 12 weeks in the future but we know that COVID-19 applications may need to start sooner. We will be flexible with the project start date and it can be earlier than the date stated on the form.

National Lottery Awards for All Northern Ireland (New COVID-19 restriction)

A quick way to apply for smaller amounts of funding between £300 and £10,000. Suitable for voluntary or community organisations. All the funding decisions they make for the next six months (up to £300m of National Lottery funding) will be devoted to addressing the current crisis. This is restricted to:



- Activities specifically geared to supporting communities through this crisis
- Helping organisations overcome any liquidity issues caused by Covid-19.

Standard Life Coronavirus funding

They are making funding available for work directly related to the pandemic, addressing specific challenges and helping to contribute to social change which tackles financial problems and improves living standards for those on low-to-middle incomes in the UK. Examples of type of work are: rapid analysis of key issues, modelling of new proposals (such as enhanced sick pay, help with utilities, high cost credit payments, and changes to pensions), recording impacts on low-to-middle income groups and specific advocacy and policy work on a range of issues related to income, spending and assets. Projects funded may last only a few weeks or months but some may be longer. Grants will range from £5,000 to larger amounts.

National Lottery Heritage Fund: Heritage Emergency Fund

The National Lottery Heritage Fund is making £50 million available for a Heritage Emergency Fund to support the UK heritage sector as an immediate response to the COVID-19 crisis. They will be investing the £50m where it is needed most, by providing short-term funding for organisations delivering heritage projects or running previously funded projects, and safeguarding heritage sites they have previously invested in to ensure they are not lost to the public. They are now accepting applications for funding from £3,000 to £50,000, and you will be able to apply until 30 June 2020. FAQ

The Princes Countryside Fund

Offering £100k of emergency funding for farming & rural community groups which are providing support during the COVID 19 crisis. Groups can **apply for up to £2,500** of funding. Applications close Wednesday 15th April.

Tesco Bags of Help COVID 19 Communities Fund

A new short-term fund to support local communities with a streamlined application and payment process to make it easier to get funds distributed quickly. Provides single payment awards of £500 to organisations who are supporting vulnerable groups.

Enkalon Foundation Coronavirus Community Support Fund

The Enkalon Foundation will move the focus of their modest funding pot to charities and community organisations helping people who are isolated and vulnerable in their local communities at this difficult time. As a small funder they focus their funding based on their core objectives in the former Antrim Borough Council area. All potential applicants need to contact the administrator directly with an outline of the new or existing project.

Awards for All

The small grants programme delivered and funded by The National Lottery Community Fund in Northern Ireland.

The main aim of the programme is to bring real improvements to communities and to the lives of people most in need by funding projects which involve people in their communities, bringing them together to enjoy a wide range of charitable, community, educational, environmental and health-related activities.

Grants awarded are between £300 to £10,000.

A rolling programme with no deadlines.

• Key Phrases: People-Led & Strength Based





Supporting positive change in the community. The People and Communities programme is designed to support you to work with local people to bring about positive changes in your community. A community could be a geographical area or a community of interest.

Grants awarded are between £30,000 to £500,000.

Deadline: Ongoing

What can be funded?

The programme will support projects that clearly meet the following two programme outcomes:

- People make changes that improve their lives.
- Communities build on their strengths and share learning.

Key Phrases: People-Led; Strength Based and Connected

Empowering Young People

Empowering Young People funds projects that give young people in Northern Ireland aged 8-25 the ability to cope with challenges in their lives.

Grants awarded are between **£30,000 to £500,000**. **Deadline:** Ongoing


What can be funded?

They will fund projects that meet at least one of the following outcomes:

- More young people are ready for education, work and training
- Young people have better relationships with their support networks and communities
- Young people have improved health and well being

Empowering Young People can cover 100% of your project costs so there is no need for you to find match funding.

They can consider revenue costs which can include salary costs for project workers, rent, electricity, heating, volunteer costs, travel costs. 10% of the amount you are asking them for can be used towards capital expenditure: this can include modifications to buildings or small scale refurbishment.



Everybody Active

From Monday 18 March 2019, the Sport NI Every Body Active 2020 Small Grants Programme 2019-20 for projects taking place before 29 January 2020 launches. The programme aims to prioritise investment in sports clubs, community groups and governing bodies of sport, especially those based in areas of greatest need that will deliver increased sports participation.

Priority will be given to projects which aim to increase participation among traditionally underrepresented groups which include:


- Women and girls
- People with a disability;
- Those living in areas of greatest social need (specifically people living within the top 25% of wards designated by NI Multiple Deprivation Measure Index 2010)

Council will consider up to 100% funding of total eligible costs up to a maximum of £2,500. Projects must be completed by 29 January 2020.

- Applications will be assessed in the order they are submitted, therefore it is advised to apply early as this
 is a competitive process.
- Council will have the right to close the scheme before the stated closing date should the budget be fully allocated.









CRC Community Relations/Cultural Diversity Grant

Scheme details

Grants of up to £10,000 are available per application to this scheme however most awards are between £2000 to £5000.

The scheme is aimed at locally based groups such as community development groups, cultural organisations, women's groups, church groups, tenants associations and other organisations and groups involved in community relations, reconciliation projects and cultural engagement.

The scheme is aimed primarily at projects involving adults i.e. 16+.

- To develop opportunities for groups to explore their own cultures, beliefs and traditions, thus increasing their capacity to develop relationships of trust with those of different traditions and values.
- To develop opportunities for groups to extend their knowledge and understanding of others' cultures, beliefs, traditions; increasing their acceptance of and respect for diversity.

Central Good Relations Funding Programme 2020/21

There are two categories of funding available:

- Project Funding
- Small Grant Funding

Project Funding

Projects will not normally run for longer than 12 months. The majority of grants awarded will not exceed **<u>£50,000</u>**.

The following list provides examples of what funding may be awarded to enable you to deliver project:

- Fees for facilitators/speakers
- Project staff salaries
- Promotional costs
- Rent
- Resource materials
- Seminars
- Travel costs
- Vehicle rental
- Venue hire

Small Grant Funding

Small Grants of up to £1,000 are available.

Small Grants are available for productive, time-bound projects that contribute to the promotion of good relations.

Small Grants may be used to enable projects and organisations to cover small purchases for purposes which are in line with the funding aims.

This will normally entail the submission of one funding claim to The Executive Office.

The application process for Small Grant Funding will remain open throughout the year







Victoria Homes Trust-improving the lives of children in Northern Ireland since 1882

The Victoria Homes Trust is a small independent grant-making trust based in Northern Ireland which funds only registered charities in Northern Ireland. The purpose of the Victoria Homes Trust is to assist the physical, mental and spiritual development of young people under 21 years of age. The Trust's policy is to provide small grants in support of local projects which benefit children and young people.

The main objects of the Victoria Homes Trust are:

To help and educate young people of both sexes under the age of 21; To assist in the training of young people to enable them to maintain themselves at the termination of their education and training;

The needs of young people are many and the Trust does not wish to overly restrict the scope of applications received by it, however, projects addressing the following needs of children and young persons are particularly welcome:

- Alcohol and drugs abuse
- Homelessness
- Counselling for those in need of guidance, advice and support

GRANT RANGE

It should be noted that the majority of grants are in the range of £500 to £2,500. When applying please remember that the approximate grant total per annum for all projects is £40,000/£50,000.

Who can apply?

You must be a charity registered in the UK to apply. (or on the deemed list of charities with the Charity Commission for Northern Ireland and awaiting the call forward to apply - you may be asked for evidence of your status in this regard)

Lidl Community Works: Sport for Good

Through their Lidl Community Works Sport for Good initiative, £160,000 will be invested in sports equipment for youth sports clubs across NI. Groups can be nominated online for up to £4000 of sports equipment using the 10 digit code at the bottom of a LIDL receipt.

Scheme details

Background

1 in 4 local young people struggle with their mental health in Northern Ireland*, a very worrying statistic for any parent or guardian to hear. Taking part in sport has been shown to have both physical and mental benefits for children. 


Dormant Accounts – What we heard

Foreword

Northern Ireland has a diverse voluntary, community and social enterprise (VCSE) sector that makes a positive impact on many people's lives. However, cuts to public funding and increasingly complex social challenges, mean the sector is largely operating in crisis mode, feeling overwhelmed, exhausted and unable to find the breathing space to explore options for sustainability, development and diversification.

Consultation took place between October and December 2019.





What are dormant bank accounts?

Dormant accounts are UK bank and building society accounts that have been untouched for 15 or more years, and where banks and building societies are unable to trace the customer who owns the account.

 Northern Ireland is to receive £22 million from the Chancellor's £750 million Covid-19 charity crisis package.
 NI share calculated under what is known as the 'Barnett Formula'.

This is the latest update from NICVA

- DfC officials are working with colleagues across other government departments to prepare a scheme for Ministerial approval.
- Department for Communities are in discussions with the Department of Finance to create a scheme to allocate the resources.
- The funds will be targeted on those charities who are funded by donations, fundraising events and also earned income. In many cases, the services are still needed but the money to pay for them has evaporated almost overnight.

It is hoped that the scheme, application process and award criteria will be announced shortly.




